No other allowances will be admissible. The applicant should not be more than 65 years of age as on the closing date of application.

- 1) Master's Degree of a recognized University or institution in Anthropology or Sociology or Social work.
- 2) Two years working experience in related fields.

3) At least 10 years of working experience in any organization of the Central Government/State Government, Autonomous Body or PSU. He should have knowledge of working on Computer.
